- The school will provide well equipped Laboratories, Library and other facilities as per norms of the Board. The 6. relevant books as per the academic level of students shall be made available in the library.
- The School should have at least one adequately equipped computer lab with a minimum of 10 computers and 7. would ensure computer student ratio of 1:20 at least. Proper software along with facility of Broad Band connectivity with the feature of 'internet always on' from any service provider to be ensured.
- The schools affiliated and running upto Senior Secondary Level will provide suitable facilities including the 8. equipment in laboratories/workshops and games for classes XI and XII as per requirements laid down in rules.
- The school will also abide by the conditions of Recognition/NOC prescribed by the State Government concerned. 9.
- The school is required to restrict the number of sections as per the infrastructure facilities available in the school 10. as per rule 10.6 of Affiliation Bye-laws. The optimum number of students in a section of a class should not be more than 40 and number of students at middle, secondary and senior secondary level of the school shall preferably be proportionate to each other.
- The section teacher ratio of 1:1.5 is to be maintained to teach various subjects and school shall appoint 11. qualified and trained teaching staff on regular basis as per provisions of Affiliation Bye Laws of the Board
- The school and its records shall be open for inspection by an officer/official of the Board or an authorized 12. representative of the Board/State Educational Department at any time and the school shall furnish information as may be asked for by the Board/State Government from time to time.

No capitation fee or voluntary donations for gaining admission in the school or for any other purpose should be charged / collected in the name of the school and the school should not subject the child or his or her parents or guardians to any screening procedure in accordance with Rule No. 11.1, 2 & 3. Also, as per Chapter II, Rule No. 11.1 of Affiliation Bye-Laws, fees charged should be commensurate with the facilities provided by the institution.

- School will not prepare any student/ start class for any other Board except CBSE from their CBSE affiliated 23. school building/ premises
- As per rule 13.12 (ii), no affiliated school shall endeavour to present the candidates who are not on its roll nor 24. shall it present the candidates of its unaffiliated Branch/School to any of the Board's Examinations.
- Running of classes of coaching institutions in the school premises in the pretext of providing coaching to the 25. students for various examinations is not approved by the board. Strict action would be taken on defaulters
- Each school affiliated/ to be affiliated with the Board shall frame Service Rules for its employees which will be as per Education Act of the state/U.T., if the Act makes adoption of the same obligatory, otherwise as per Service 26. Rules given in Affiliation Bye Laws. Further, Service Contract will be entered with each employee as per the provisions in the Education Act of the state/ U.T., or as given in Appendix III.
- Pay and allowances to staff should be revised from time to time to bring it at par with that of State Government. Further, Salary and service conditions of staff should be fixed in accordance with rule no. 3.3 (v) and rule no. 27. 10.2 as appended below:
 - a) The school in India must pay salaries and admissible allowances to the staff not less than the corresponding categories of employees in the State Government schools or as per scales etc. prescribed by the Government of India.Further, the service conditions as per Rule 10 and Rules 24 to 49 of Affiliation Bye-Laws shall also be adhered to.
 - (b) Salary should be paid through Electronic Clearing Service (ECS) from the date of first appointment of the teachers on probation.
- Continuous sponsoring of students at Board examination is to be made as per rule 13.12 (iv). Failure to do so will lead to suo moto withdrawal of the affiliation of the school for Secondary and Senior Secondary Examination 28. as the case may be
- School infrastructure and teachers should be made available as per rule no. 13.4 for examinations 29. conducted by the board and evaluation of answer scripts
- As per rule no. 8.8 (iv & v), every affiliated school is required to develop their own website containing 30. comprehensive information such as affiliation status, details of infrastructure, details of teachers, number of students, address-postal and e-mail, telephone nos. etc.
- Strict adherence to the provisions of Wild Life Protection Act while procuring plants and animals for the use in 31. laboratories by the school must be made in accordance with circular no. 03 dated 21 May 2013
- As per rule 15.1 (d), the school will follow the syllabus on the basis of curriculum prescribed by NCERT/ CBSE and text books published by NCERT/CBSE for the Middle classes as far as practicable or exercise extreme care while selecting books of private publishers. The school is directed to submit an affidavit duly notorized with in 15 days of Issuance of grant letter, as an instrument of acceptance of terms of affiliation. The school is not allowed to alter or make any changes in the contents of the affidavit. The format of affidavit is attached with this letter.

The school shall apply for further Extension of General Affiliation 'Online' through www.cbseaff.nic.in with 41. prescribed fee and other essential documents as per the time period given by the board in this regard before the expiry of the date of General affiliation otherwise penalty as por rules will be charged for late execution of

The school should not start Class IX/X/XI/XII (as the case may be) without written approval of the Board. The 42. Board shall not be responsible for any consequences in case class IX/X/XI/XII are started without obtaining the prior approval of the Board and without following the Affiliation Byelaws.

It is mandatory for every affiliated school to become a member in the local Sahodaya of CBSE schools. 43.

In case of established violation of Affiliation Bye laws, directions given in the circulars and any of the above 44. mentioned conditions by the school, the school would be liable for disaffiliation under Chapter V,Rule No. 17 of Affiliation Byc-laws.

Some of the important rules to be adhered to by the school were given above for drawing specific attention of the 45. school authorities. However, the school authorities are required to acquaint themselves with the rules contained in Affiliation, Examination Bye-laws and circulars issued by the Board from time to time. Any laxity in following rules/instructions of the Board will lead to action against school as per Rule 17 of Affiliation Bye-laws.

46. The school is required to contact the concerned Regional Office of CBSE for allotment of school number and password for online Registration of candidates.

Concerned Regional Office is requested to allot the School number and create new email id of school 47. (SchoolNumber@cbseshiksha.in), this will be used for all online activities and official communication with the Board . The School is requested to complete the process and use the email ID as per above instructions and are 48. also requested to ensure that:-

a. This email ID will be used for communication with CBSE only. Do not use this email ID with other people or organisations.

b. This email ID is not to be printed on the school letter head, to avoid its circulation in the public.

c. If there is a change of the Principal, proper handing over of this email ID (User ID and Password) be done between outgoing and incoming Principal. d. All the examination related work and all CBSE related correspondence will be done on this email ID

The school shall be solely responsible for any legal consequences arising out of the use of school name/ logo/ society/ trust or any other identity related to running of school affiliated to CBSE. The school shall also be liable to 49. bear all legal charges incurred by the Board, if any, arising out of these circumstances. The school is required to renew the safety certificates from time to time.

The affiliation of the school is subject to the fulfillment of the following special conditions. The school is required to comply with the conditions mentioned below and report specific compliance with documentary and photographic evidence ONLINE within a period of 30 days from the date of this letter. In case of non compliance of the these conditions the school will be liable for action as per rules:-

- * The number of sections of the school shall be restricted to 26 as per the number of class rooms reported and further increase shall be subject to specific approval of the Board on the basis of the request of the school as per affiliation bye laws,
- * The school has submitted revised infrastructure detail without verifying from IC. However, IC has reported class rooms of 450 sq.ft. each and computer science lab of 578 sq.ft. in already submitted online IC Report whereas class rooms should be of 500 sq.ft. each and Computer Science Lab should be of 600 sq.ft. as per Affiliation Bye Laws. Therefore, the school is required to (1) shift Computer Science Lab into bigger room of minimum 600 sq.ft. within 3 months, (2) restrict number of students upto 36 in each class room of 450 sq.ft. and (3) construct class rooms of 500 sq.ft. in future as per Affiliation Bye Laws.
